CCM Practitioner

It is designed for those who intensively participate in or are responsible for contracts and contract processes, such as contract managers, bid managers, lawyers, vendors and project managers.

The course is taught over 1 month, includes 4 days of classroom teaching, and will provide you with insight into CCM processes, activities and best practice - from sourcing options to contract close out and lessons learned. This knowledge will enable you to immediately improve your organization's commercial and legal contract management.

THE LIFECYCLE OF THE CONTRACT

Contract and commercial management is a multidisciplinary subject area and is based on a commercial and legal perspective.

A contract manager is responsible for creating an overview of processes and activities. He or she also has a responsibility to collect and share knowledge with their organization.

CCM Practitioner is based on the WorldCC's process model of the life cycle of the contract. This model has 5 main phases, each containing activities that optimize the performance of the contract:

- **Initiate**
- **Bid**
- **Development**
- **Negotiation**
- **Management**

These activity phases ensure higher commercial yield and reduce the risks that can prevent business objective/aim achievement.
